Outdoor Improvements Phase II Update - Director Jacobsen reported that Phase II went out to the formal bid process on February 24th. A pre-bid meeting was held on March 4th. Final bids are due to be submitted by Friday, March 21, no later than 10 am. Director Jacobsen also mentioned that other table options are being considered, which may be more ADA compliant.

Automatic Door Operators - Director Jacobsen explained that some staff and patrons face challenges navigating the bathroom doors for various reasons such as needing a walking ad, a wheelchair, or have limited arm strength or mobility. Although the current doors meet ADA compliance standards, accessibility improvements could be made by installing push-button access for the six main bathrooms.

Director Jacobsen asked for the board guidance on whether to include these improvements in next year's special reserve budget. The consensus of the board was for Director Jacobsen to proceed with budgeting for this improvement, to seek quotes, and to also research grant funding that may be available.

Imaginative Play Area – the improvements to the Imaginative Play Area in Youth Services have been completed. Both staff and patrons are excited about the updates made to the space which features an outdoor market setup, register, and other items designed to inspire creative play.
